# **Advisory Committee Minutes**

#### 1. Welcome

#### 3. Minutes

  - Financial
    - Ruth gave a brief Financial Summary for month ended December 2023 and February 2024. Ruth said the office ended 2023 at a deficit of \$13,382 and that the office had to use the Prudent Reserve to make up the difference. Ruth said that currently the office is operating at a deficit of \$34,592 due to Outreach. But, it should improve as the month continues.
    - Fund Drive: Ruth explained that the office is not mailing Fund Drive packets due to inaccurate group contact information, but we mail when requested and they also pick up when they come in.
